

## **KANDAHAR RACING - TERMS & CONDITIONS**

- 1. By booking online, parents/guardians are authorising K Racing to act in loco parentis, and are agreeing to be bound by K Racing's full T&C's, our athletes code of conduct, our parents code of conduct, our anti-bullying policy and our disciplinary procedures. As a Snowsport England affiliated training organisation, K Racing abides by the SE 'Snow Safe' safeguarding policy.
- 2. All camp applications for trainees must be made by parents/guardians online at www.kandaharracing.com. Due to the complexities of organising and running training camps, bookings will be accepted by Kandahar Racing only for the whole period of each camp or for certain parts of each camp (usually complete weeks), details of which are set out in the online information for each camp. Participants will be accepted for periods of less than a complete training option only at the discretion of the manager, but payment must still be made for the whole training option attended.
- 3. Deposits must be paid within 14 days of submitting application forms and receiving an invoice. Deposits cannot be refunded in the event of cancellation by you. We strongly recommend you take out cancellation insurance.
- 4. Payment in full must be made by the date stipulated for each training which will usually be 6 weeks before the start of the training. Failure to pay in full by the due date will result in cancellation of your booking and the loss of deposit. We strongly recommend you take out cancellation insurance.
- 5. By booking online, parents/guardians are confirming to Kandahar Racing that their children are attending training camps with; comprehensive winter sports insurance that covers ski racing, ski race training and mountain helicopter recovery, a valid passport, a valid EHIC card, a completed medical consent form and a completed travel consent form.
- 6. For each training, a minimum number of people need to book to enable the training to take place. Kandahar Racing will assess whether the minimum number has been achieved and inform you as soon as reasonably practicable and usually not less than 4 weeks before departure. If it becomes necessary to cancel a training for this reason Kandahar Racing will refund all sums paid to Kandahar Racing in these circumstances, but you will not be entitled to compensation. We strongly recommend you take out cancellation insurance.
- 7. In the event of curtailment, or of sickness or injury, no refunds will be made to you unless Kandahar Racing has obtained a full refund from the relevant service provider(s). It is essential that lift passes are surrendered to Kandahar Racing immediately that it becomes apparent that they can no longer be used together with any supporting medical certificate (if not already in Kandahar Racing's possession) that the lift company may require. Similar requirements apply to hire equipment. Refunds cannot be guaranteed as the terms and conditions of the appropriate lift company or other service provider will apply. We strongly recommend you take out cancellation insurance.
- 8. In the event of cancellation or curtailment or inability to ski because of inclement weather or lack of snow, Government advice, Foreign and commonwealth office advice or specifically epidemic or pandemic related cancellation no refunds will be made to you unless Kandahar Racing has obtained a full refund from the relevant service provider(s). In the event of lack of snow, or inclement weather, Kandahar Racing will endeavour to re-site the training, however this may result in extra costs which will be passed on to you. We strongly recommend you take out cancellation insurance.
- 9. All Kandahar Racing staff are professionally qualified, are first aid trained and have enhanced DBS disclosures. Professional coaching qualifications cover all ski training activities and elements of fitness training. Staff may also supervise trainees participating in a multitude of other activities including but not limited to swimming, cycling and hiking. Parents must advise our staff if they do not want their children to participate in extra activities beyond ski and fitness training. Kandahar Racing is not equipped to care for trainees with special needs apart from special dietary requirements.
- 10. Behaviour. If a trainee's behaviour is such that in Kandahar Racing's reasonable opinion a training is at risk of being disrupted, another trainee is inconvenienced, or the trainee puts the reputation of Kandahar Racing in jeopardy, the trainee will be asked to leave the training. If a trainee is found to have been drinking alcohol, taking illegal drugs, stealing, involved in sexual activity or generally displaying antisocial behaviour, the trainee will be asked to leave the training. In these instances, the trainee will be sent home at the expense of the parents, no refund will be made and the cost of any other accommodation and travel expenses will be the responsibility of the trainee concerned (or the trainee's parents if under 18). Trainees may be barred from attending future training camps and asked to find an alternative training provider, advance camp payments will only be refunded more than 12 weeks in advance of future camps.
- 11. Outliers, i.e. trainees who make their own travel and accommodation arrangements, will be accepted subject to availability of places on camps. Kandahar Racing will only provide outliers with ski/race training on the slopes but fees are subject to the service providers of Kandahar Racing for accommodation, travel and other associated expenses to provide a coach on the snow if cancelation is actioned as set out in Clause 8. Lift passes at the group rate may be purchased by prior arrangement which are subject to the conditions above. Outliers will be responsible for their own transport to and from the slopes. In view of difficulties encountered in the past with hoteliers, outliers will only be able to use the accommodation arranged for other participants by Kandahar Racing for meals by prior arrangement. Outliers will not be entitled to use such accommodation for other purposes such as ski waxing or eating packed lunches, neither will they be permitted access to resident trainee's bedrooms.



- 12. Occasionally photographs of trainees may be used in publicity material relating to Kandahar Racing. Signing these terms and conditions confirms consent to the photograph being used. Where possible the name of the trainee will not be used unless Kandahar Racing have obtained the consent from the parents/guardians of the trainee. Photographic opt out forms must be submitted if you wish not to have your child's photograph used for publicity purposes.
- 13. FIS Flexi programme participants will be given priority for race entries to International FIS races and transport options on optional weeks if they 1. Have under 200 points on the latest FIS list in any one technical discipline with a valid international FIS speed licence, 2. Have participated in a recent time trial with K racing for any races where we have limited spots within K Racing programme athletes, FIS points will be disregarded if a time trial takes place for entry priority.
- 14. Optional weeks will have limited spaces due to van seats and staff assignments and these will be confirmed 4 weeks prior to departure please do not book any travel until these weeks are confirmed. Any weeks which have not been able to be confirmed by Kandahar Racing but are on your core payment direct debit will be credited in February of that season.
